For Taqa, acquisitions are one way it could reach its ambitious growth targets. In November, it said it was aiming to have 150GW of gross power generation by 2030, trebling its previous target. It currently has 24GW of gross power generation. The company said on Wednesday: "No agreement has been reached with CVC, GIP or Criteria Caixa.

Who owns TAQA?

TAQA's business roots lie in the local power and water desalination plants in Abu Dhabi. The company supplies around 85% of the Emirates power and 90% of water demands, through the operation of eight power and desalination plants in the UAE. The plants are 54% owned by TAQA, 6% by ADWEA and 40% by various international shareholders.
