This is because they generally fall under permitted development rights, which allow homeowners to make reasonably sized changes without getting permission. The exceptions to this rule are typically flats, listed buildings, homes in conservation areas, and ground-mounted installations. What are the building regulations for solar panels?

Can a rent-a-roof company install solar panels?

Where an installation is owned by a rent-a-roof company,we would expect there to be a signed 'agreement' between the relevant parties,i.e. the homeowner and the rent-a-roof company, such as a lease agreement, with the homeowner agreeing to rent their roof to the company for the purposes of installing solar PV panels.
