The IEC also manages global conformity assessment systems that certify whether equipment, systems, or components conform to its international standards. In 2016 and 2020, IEC published two key associated standards: BS EN IEC 62446-1:2016Photovoltaic (PV) systems - Requirements for testing, documentation and maintenance.

### Are there building regulations for solar panels?

There are building regulations for solar panels, as there are for most home improvements. These government regulations are frequently updated to ensure that any alterations made to properties don't threaten the safety or health of people who live or work in them.

### What are the requirements for a PV installation?

Virtually all domestic PV installations will fall under the scope of Part P. Part P requires the relevant Building Control department to be notified and approve the work. There are two routes to comply with the requirements of Part P: Notify the relevant Building Control department before starting the work.

#### Are solar PV installations notifiable?

To clarify, what is certain is that nearly all domestic electrical work is notifiable under Part P of the Building Regulations (see below) and a solar PV installation is nearly always notifiable electrical work.
