How much solar power will the UK need by 2050?

To meet the UK government's net zero target, the Climate Change Committee estimates that between 75-90 gigawatts (GW) of solar power will be needed by 2050. Analysis by Solar Energy UK indicates this would mean solar farms would, at most, account for approximately 0.4-0.6% of UK land - less than the amount currently used for golf courses.

How much solar energy can I produce?

There isn't a maximum amount of solar energy you can produce. However, your solar panel installer must inform your Distribution Network Operator (DNO) - the company controlling the hardware that supplies your area with electricity - before installing a system with a peak power capacity above 3.68 kWp per phase.

How many solar panels do I need?

Do you need planning permission to install solar panels?

Current rules that require businesses to apply for planning permission if solar panels will generate more than one megawatt of electricity will also be scrapped, meaning organisations will be able to install more solar panels on rooftops without the delay and cost of applying for planning permission.

How many solar panels can you get without DNO permission?

On a single phase supply, you can have up to a 3.68 kW inverter without prior approval from the DNO (as it is granted retrospectively). However, the average domestic solar system is 4 kWp, equivalent to roughly 10-13 solar panels.
