

Will Spain raise its share of renewables by 2030?

According to a draft government report issued in June, Spain's goal is to raise the share of renewables to four-fifths by 2030. The new climate plan includes higher targets for solar and wind power capacity as well as energy storage.

Spain has been one of the long-time leaders in the European renewables sector, making substantial investments in solar and wind capacity over the last 10 years. In particular, the country was an early adopter of onshore wind, technology that now accounts for more than 20% of Spain's power generation.

How did renewables affect Spain's electricity mix?

The installation of photovoltaic (PV) plants beginning in 2007 played a key role in this increase, doubling the renewables' share in Spain's electricity mix from 20% in 2008 to 40% in 2013. After this period of growth, the share of renewables in Spain's electricity generation leveled off, reaching 37% by 2019.

However, the number of projects and MWs developed under this royal decree was not significant and the economic regime set forth therein was based on a complicated formula, with no guarantee of stability in the future.
